



“BSIB RISING STAR SCHOLARSHIP PROGRAMME”

The Berjaya Sompo Insurance Berhad (“**BSIB**”) Rising Star Scholarship Programme (“**the programme**”), will be awarded to eligible individuals who have received offers to pursue or are currently pursuing undergraduate studies subject to meeting The Programme’s requirements and the terms and conditions stated herein (“**Terms and Conditions**”)

GENERAL TERMS AND CONDITIONS

1. By submitting the application for the programme to BSIB, the applicants are deemed to have read, understood, accepted and agreed to be bound by the Terms and Conditions.
2. BSIB has the liberty to unilaterally extend or re-schedule the date or period open for the programmes .
3. BSIB may terminate or suspend the programme at any time at its absolute discretion in which case, BSIB may elect not to award any scholarship. If BSIB resumes the programme, applicants shall abide by BSIB’s decision regarding the continuation of the programme subject to the existing or new Terms and Conditions, if any.
4. BSIB’s decision on all matters relating to the programme shall be final, conclusive, and binding on the applicants, and no appeal against its decision will be entertained.
5. By submitting the application for the programme, applicants have consented and agreed to permit BSIB to contact and liaise with the relevant higher learning institution, college or university (collectively, referred to as “**Institution**”) to verify that applicants are officially registered/ enrolled with the Institution.
6. All information, including personal data submitted by the applicants to BSIB for the programme may be used, processed and disclosed by BSIB for the purposes of the programme including but not limited to, verification with the Institution, publication and advertisement of the programme to the public within or outside Malaysia, including Sampo group of companies.
7. By submitting the application for this programme to BSIB, the applicants have consented to the use, process and disclosure of his/her personal data collected by BSIB for the aforesaid purposes. ,
8. BSIB ensures that practicable security measures are taken to prevent unauthorized access, alteration, disclosure or destruction of the applicants’ personal data. Applicant’s personal data collected for the programme will not be kept for any longer period than necessary. BSIB will take reasonable actions to ensure that such personal data will be destroyed or permanently deleted if no longer required.
9. These Terms and Conditions shall be governed by and construed by the laws of Malaysia.



SUBMISSION OF APPLICATION REQUIREMENTS

1. Application must reach BSIB latest by ~~30th April 2023, 11:59 pm~~ 21st May 2023, 11.59 pm
2. Application must be submitted through email at hr@bsompo.com.my.
3. The subject of the email: **BSIB Rising Star Scholarship**.
4. Application must be submitted together with the following documents:
 - a. Copy of NRIC of the applicant and parents or guardian.
 - b. Curriculum vitae (personal information and involvement in extra co-curricular activities).
 - c. *Copy of applicant's university acceptance letter
 - d. *Copy of trial results
 - e. *Copy of latest semester result with current CGPA
 - f. Copy of 3 months' pay slips (parents or guardian) or verification letter from the employer (for salary without pay slips) or verification letter from the head of the local community (for self-employed)

*whichever applicable

ELIGIBILITY CRITERIA AND COVERAGE

1. Open for Malaysian only.
2. Open to any course/field of study, public and private universities in Malaysia for Pre-U (foundation or matriculation), Diploma and Degree, full-time, conventional, hybrid, or online delivery method.
3. Applicants from households earning below RM5,000 per month.
4. Applicants age below 23 years old in 2023.
5. Applicants may be required to submit further proof of their eligibility within such timeframe as may be required by BSIB, failing which BSIB shall be entitled to reject the application.

ACADEMIC REQUIREMENTS

1. SPM Applicants: Trial results with at least 7As in any subject.
2. STPM Applicants: Trial results with at least 2As in any subject.
3. UEC Applicants: Trial results with at least 6As in any subject.
4. Pre-U and Diploma Applicants: Latest result with at least 3.50 CGPA.

Applicants must have a confirmed placement in public and private Institution in Malaysia for the above categories. Applicants currently pursuing Pre-U, Diploma, or Degree programme are required to complete 1st semester with a minimum CGPA of 3.5.

Successful applicants are required to maintain a minimum of 3.0 CGPA until graduation, as such, for this purpose, BSIB will request the semester result to be submitted to the HR Department.



AMOUNT

1. Up to RM20,000 per annum per person per programme (100% tuition fees or as a top-up cost of living allowances or maximum RM20,000 whichever is lower), and to be credited directly to the successful applicants' bank account.
2. Acceptance to the internship programme with BSIB will be based on the available quota.

DISQUALIFICATION

1. BSIB reserves the right to reject the application and/or revoke the decision (at any stage of the programme if:
 - a. The applicant is ineligible or does not meet the Eligibility Criteria; or
 - b. The applicant breaches any of these Terms and Conditions, other rules and regulations of the programme, or violates any applicable laws or regulations; or
 - c. In BSIB's sole determination, it believes that the applicants attempted to undermine the operation of the programme by fraud, cheating, falsifying the documents, or deception.
 - d. The applicant failed to maintain the minimum of 3.0 CGPA until graduation, dismissed or withdrawn from the University, or changed course/field of study.
2. BSIB reserves the right to award the scholarship to the reserve applicant(s) in substitution of any of the applicants who may subsequently be disqualified.
3. In the event of a disqualification after the scholarship has been awarded, BSIB reserves the right to demand the return of the money from the disqualified applicant.

NOTIFICATION OF THE APPLICANT

1. The applicant will be selected based on the completed documents, suitability, credentials, and qualifications to suit the objective of this programme.
2. Only successful applicants will be notified via an official offer letter.
