Students who are pursuing the UTAR foundation or undergraduate degree programmes are eligible to apply for the UTAR INTEREST FREE loan for each year of study up to a maximum of RM15,000 per year.\*

## UTAR Student Bridging [INSTANT] Loan

SHORT TERM / INSTANT FINANCIAL AID TO SUPPORT STUDENT'S LIVING ALLOWANCE.

### **Eligibility Criteria**

- Citizen of Malaysia
- Currently enrolled in full-time programme at UTAR and not on suspension or leave of absence.

# Guarantor Requirement for UTAR Loans

## UTAR Loans

Students must have ONE guarantor for any UTAR Student Loan, UTAR Student Bridging Loan, or UTAR Bridging (Instant) Loan that exceeds RM1,000.00.

#### Criteria

- Malaysian
- 21-60 years-old
- Working in Malaysia
- With monthly BASIC & Net monthly salary of RM2,000
- Not filed in CTOS
- Not a guarantor to another UTAR Student Loan holder

#### Supporting Documents

##### **For Under-Employed**

- A Copy of I.C.
- 3 Latest Months of Pay Slips
- Employer Confirmation Letter

##### **For Self-Employed**

- A Copy of I.C
- Latest Year of Income Tax Document with Payment Receipt to LHDN

##### **IMPORTANT**

- Registered Students are to carry out application via Student Portal.
- The Scholarships and Financial Aid Committee will interview the students.
- Successful applicants are to enter agreement with UTAR.
- All application must be substantiated with documents.
